



NatWest Adapt Prize Draw Terms and Conditions

Can I enter the prize draw?

Prize draw open to:

- new customers applying for an Adapt account between 29th June 2026 and 23:59 hours on 17th August 2026.
- and existing Adapt customers.

Prize draw not open to:

- Employees of The NatWest Group of companies, their families or anyone associated with this draw.

How do I enter?

For new customers:

- You're automatically entered in the prize draw if you **apply for a NatWest Adapt current account** between 29th June 2026 and 23:59 hours on 17th August 2026 **and successfully open the account** following ID checks by 23:59 31st August 2026.
- We won't accept entries received after the closing date.
- You have the option to opt out of the prize draw at any time before the 31st August by emailing adapt@natwest.com with their full name, current account sort code and account number.
- Opting out has no effect on how you use your Adapt account.

For existing Adapt customers:

- If you already held a NatWest Adapt account prior to 29th June 2026 you can enter by emailing adapt@natwest.com with your full name, current account sort code and account number for one entry per person into the relevant Adapt Prize Draw.
- All email entries must arrive within the prize draw period to be eligible. Entries are not returnable.

Entries not submitted in accordance with these rules, delayed, damaged, incomplete, altered or illegible will be disqualified.

One entry per account opened. One prize per entry.

What is the prize?

The prizes are gift cards, which are non-transferable and non-exchangeable. No cash alternative is available. The prizes will be awarded in the order in which they are drawn below:
